












- Improve oral health
- Reduce harms associated with substance use
- Prevent deaths from suicide
- Improve immunization rates
- Protect the population from communicable diseases

## Public health goals in support of healthy aging

- Elevate healthy aging and caregiver health into civic discussions about healthy communities
- Promote multi-generational approaches to caregiver support
- Promote policies that support worksite wellness, which include caregiver support resources

#### **Tactical Strategies:**

- Develop a collective vision of what we need to be doing as a state to serve the aging population
- Identify the public health role moving the work forward



### **Recent accomplishments**

- Raised the civic conversation in Oregon using Public Health's communication infrastructure: <u>Place Matters Oregon</u>.
- Published the <u>Health Within Reach Blog</u> and Data Within Reach Webinar.
- Convened partners outside of public health to enhance civic dialog about healthy aging.
  - Across the country and in Oregon
- Developed Oregon's first Healthy Aging Index
  - Overall health
  - Physical health
  - Preventive services
  - Psychosocial
  - Stress

- Cognition
- Social determinants of health
- Caregiver health
- End of life

### **Opportunities**

- Aging related programs and activities have been happening for a long time in Oregon:
  - Legislative long term care task force
  - Governor's Commission on Senior Services
  - BRFSS: cognitive impairment and caregivers
  - Oregon Senior Falls Prevention project
- While conversations are happening across many sectors, a population wide and coordinated perspective is lacking.
- Opportunities to establish a clear role for public health, highlight the work of partners, and elevate the need for collective, cross-sector action.



## What is next for State Health Assessment & Planning

- PHD is convened partners to inform the SHA. The SHA is to be released soon.
- Using Mobilizing Action for Policy and Partnerships (MAPP) framework with focus on health disparities
- Extensive community input
- SHA will inform future State Health Indicators
- Planning for 2020-2024 SHIP will begin this summer
