

Coast to the Cascades Region – Benton, Lincoln and Linn Counties Oregon



Memorandum of Understanding

**MEMORANDUM OF AGREEMENT
THE COAST TO THE CASCADES COMMUNITY WELLNESS NETWORK 2012**

This Memorandum of Agreement (MOA) is between Coast to the Cascades Community Wellness Network member organizations (hereinafter referred as the CCCWN) for the purpose of defining roles and responsibilities in current and future development of projects, initiatives and activities between the identified organizations.

The MOA may be amended to change the terms and agreement or to include additional representatives. This MOA may be terminated by any representative upon 30 calendar days written notice to the CCCWN staff.

A. Structure

The CCCWN membership is comprised of the following lead agencies and partners:

The development of a sustainable collaboration between CCCWN member organizations will ensure a coordinated and systemic effort to address health issues in Benton, Lincoln and Linn Counties. The knowledge, experience and expertise of each organization will result in improved coordination of efforts to address health issues in the tri-county region. The working relationship among the aforementioned organizations is formalized in this MOA for future endeavors and sustainability.

The CCCWN will function as the lead team comprised of representatives from each listed organization. The CCCWN will communicate on an on-going basis to identify key focus areas of health in the tri-county region.

B. Mission and Vision

The mission of the CCCWN is to provide leadership to enhance the health of communities through development and support for collaborative regional partnerships in Benton, Lincoln and Linn Counties.

The vision of the CCCWN is to lead and sustain a system of partnership agencies and organizations working together to provide integrated services and programs to promote individual and community health.

C. Responsibilities and Agreements

The overarching responsibility and agreement of the CCCWN is effective collaboration. The CCCWN member organizations agree to the following:

- Participate in meetings of the CCCWN
- Share in decision-making through consensus regarding issues that impact the CCCWN
- Develop, review and approve joint projects and publications that benefit the CCCWN
- Offer training, education, resource and information to the CCCWN member organizations
- Collaborate to develop new resources and funding that promote health in the tri-county region
- Receive regional data updates and reports on health issues
- Participate in discussions on data analysis
- Direct the CCCWN assigned staff on projects, activities and initiatives
- Provide direction and oversight of funding that support the CCCWN
- Ensure materials and publications developed for the CCCWN shall be available to all members

D. Financial Participation

Each party to this agreement will cover their own expense in performing work under this memorandum of agreement. Each party will expend its own funds in a manner congruent with their own mission and vision. Parties to this memorandum agree to whenever possible and in the best interest of developing a system of care, be flexible and creative in the use of funding to support the creation of an effective system.

- Network uses Community Health Needs Assessment, Health Improvement Plans, and available data to inform what grants to pursue
- Samaritan Health Services acts as fiscal agent and provides program management
- Twelve federal and state grants between 2009-2023

Where's the Need?

- Substance Use Disorder & Mental Health:
 - Increasing overdoses across the region
 - Few prevention, treatment, and recovery services available
 - Workforce shortage
- Domestic Violence, Child Abuse, and Human Trafficking
 - Lack of awareness
- Oral Health
 - Access to care barriers
 - Integrating oral health into primary health care

Current CCCWN Grants

- **Addressing Violence in Rural Oregon Communities**
 - Four-year \$1.2million HRSA Rural Health Network Development Program grant
- **Helping Impact Women and Youth**
 - Three-year \$1million HRSA Rural Communities Opioid Response Implementation IV grant
- **Rural Communities Supporting Women and Youth**
 - Three-year \$1million HRSA Rural Communities Opioid Response Implementation III grant
- **Oral Health Co-Location**
 - Four-year \$1million HRSA Rural Health Care Services Outreach grant
- SHS acts as fiscal agent and provides program management

Regional Mental Health & Substance Use Disorder

- Lincoln County
- Conducted a Needs Assessment, reviewed available data
- Reviewed goals/objectives/priorities
- Identified prevention and treatment services
- Partnered with Linn and Benton Counties to form a Regional MH/SUD Health Coalition in 2020



Health Resources & Services Administration (HRSA) Rural Communities Opioid Response Program (RCORP)

- Funds nine programs to aimed at treating and preventing Opioid Use Disorder for people in rural areas
 - Planning
 - Implementation
 - Medication Assisted Treatment (MAT) Expansion
 - Medication Assisted Treatment (MAT) Access
 - Neonatal Abstinence Syndrome
 - Child and Adolescent Behavioral Health
 - Psychostimulant Support
 - Behavioral Health Care Support
 - Overdose Response
- CCCWN has received Planning and Implementation grants

“Bridges to Recovery” RCORP Implementation I Grant

- Used Community Needs Assessment to identify needs and focus
- Three-year, \$1 million
 - 2019-2023
 - No Cost Extension for additional six months of program activity
- Lincoln County, Oregon
- Identify partners
- Develop workplan, goals & objectives



Project Goals

Overarching Goal: **Reduce morbidity and mortality of substance use disorder (SUD), including opioid use disorder (OUD), in Lincoln County.**

Goal 1: Strengthen and expand SUD/OUD prevention services in Lincoln County

Goal 2: Strengthen and expand SUD/OUD treatment services in Lincoln County

Goal 3: Strengthen and expand SUD/OUT recovery services in Lincoln County

Goal 4: Strengthen and sustain the activities of the CCCWN Mental Health/Substance Use Disorder Advisory Committee beyond the grant period


