## YAMHILL COUNTY PARTICIPATING PARTNERS



### **Sheriff Services Coordinator**

- Tracks engagement
- Tracks participation
- Keeps statistics for CJC



#### **HHS Navigator**

- Active Outreach
- Walk-in Access (with / without LE contact)
- Program Assessment
- Navigation Support



#### **Deputy District Attorney**

- Considers deflection engagement in case reviews
- If engaged, temporarily declines prosecution
- If successful, does not file charges
- If unsuccessful, files charges

# DETERMINING ELIGIBILITY FOR DEFLECTION









 A person arrested for a single PCS un-classified misdemeanor (UCM)

OR

 A person arrested for a single PCS UCM and they have other warrants (Failure to Appear (FTA) or similar)

### ADJUSTED MODEL

 A person arrested for PCS unclassified + lowlevel, non-victim crime

#### OR

 A person arrested for PCS unclassified that has a pending unclassified PCS deflection case
